Your questions answered

1. Who is eligible for the AECT dividend?

Everyone who is an AECT income beneficiary when the dividend roll is struck. You are an AECT income beneficiary if you are a Vector electricity customer in the Trust District (Auckland City, Manukau City or northern Papakura) when the roll is struck. The dividend is paid regardless of who your electricity retailer is, as long as your name is on the power bill. In the case of rental properties, this is usually the tenant rather than the owner of the building.

2. When is the dividend paid exactly?

Every year, usually in late September.

3. Am I still eligible if I move?

Yes, as long as you're still in the Trust District on the roll date. Please note that for security reasons we cannot advise what that date is, but it is as close as practicable to the dividend payment date.

4. What happens if I move out of the District before the roll date?

If you leave the Trust District before the roll date, you won't receive any dividend payment. Under the Trust Deed, there is no provision for part or pro rata payments.

5. You've got my details wrong.Will I still get the benefit?

Yes, don't worry. You'll still receive your dividend if you're an eligible beneficiary.

Want to know how much this year's dividend will be?

We'd love to help but the total won't be decided until Vector's final profit figure is announced later this year.

Get ready for world class broadband

It's great news for Internet users with the release of the government's proposed broadband initiative. If plans go ahead New Zealand will soon boast a world class fibre broadband infrastructure for even faster communications nationwide – and a healthy boost to the economy.

At the AECT we're right behind Vector's backing of the proposal, particularly the idea that there will be local fibre companies in each region which are not controlled by a retail phone company.

This model has already been successfully used in other countries around the world, including Singapore.

Providing the fibre build stacks up commercially we will certainly be backing Vector's endeavours, and the intention to work with other lines companies to determine whether there is scope for a combined approach in responding to the government's initiative.

AECT - \$100 million into the **Auckland economy**

The economic climate has been heavy going for many Aucklanders recently, as indeed it has for the rest of the country. That's why it's great to be able to share a little good news about the \$100 million or so we anticipate the Auckland Energy Consumer Trust will be putting into communities in Auckland, Manukau and Papakura this year.

It's all thanks to our 75.1% shareholding in Vector. Between the annual dividend we pay to AECT beneficiaries and the powerline undergrounding projects Vector is completing across the Trust District, 300,000 households will again benefit to the tune of around \$100 million.

There's more about the undergrounding projects across the page. As for the annual dividend payment, over the last five years it's grown from \$170 per beneficiary to a record payout in 2008 of \$320. This year's amount will depend on Vector's financial performance, and we'll be in touch later in the year to let you know the final figure.

If you've received this copy of The Buzz at your home or business address and your name is on the power bill, you're probably in line for a payment later this year.

It all adds up to a big reason for Aucklanders to smile and who couldn't use that?

Are you getting your money direct?


Instead of waiting for your cheque to arrive in the post, you can do what around 100,000 other AECT beneficiaries do already and have it paid directly into your bank account. This way your dividend will go in on the same day everyone else gets their cheques by mail. No need to go to the bank, no waiting for the money to clear – it's yours straight away! To receive your money directly just fill in the form enclosed and post it to us free. Or if you prefer to get the money credited to your power bill instead, simply tick the box on the form and return it to us.

Just what is the Auckland Energy Consumer Trust?

The AECT is a trust set up in 1993 on behalf of customers of what was then the Auckland Flectric Power Board. Nowadays the Trust owns 75.1% of Vector. Vector is a publicly listed company that specialises in owning and managing infrastructure assets such as power lines, gas networks and fibre optic cables (find out more at vector.co.nz). So when Vector pays a dividend, 75.1% of that money comes to the AECT and is mostly paid straight to you as your annual dividend (find out more at aect.co.nz).

Going underground say goodbye to power poles

One of the ways in which the AECT makes a real difference to Aucklanders' lives is our support of Vector's undergrounding programme – replacing ugly power poles with state-of-the-art underground cables, like at this recent project in Sandringham, completed in February 2009.

Through the agreement we have with Vector more than \$10.5 million is invested in this programme every year in the Trust District. And so far it's transformed over 140 kilometres of neighbourhoods right across Auckland, Manukau and Papakura – and said goodbye to thousands of unsightly power poles!

- The money will be paid to people who are customers of Vector electricity in Auckland City, Manukau City or northern Papakura when we finalise
- The money will be paid to the person or organisation whose name is on the power bill.
- If the name on your power bill is not the same as your bank account and you want to get your dividend as a cheque or direct credit, please update your details with your electricity retailer - the AECT can't do this for you.
- If you want to get your money faster, please fill out and return the direct credit form from this pack.
